Data Protection (GDPR 2018) - Privacy Notice

We will ensure that we keep the amount of data collected and the extent of any processing to a minimum to meet this legitimate interest.

How we will use the information about you? We may share your information with your employer.

How long we keep it We will keep your basic personal data for two years after your last EUSR registration expires, after which time it will be destroyed.

What are your rights? If at any point you believe retained information is incorrect you can request to see this information and even have it corrected and possibly deleted. Providing you this information is free of charge, but charges may apply for excessive requests. If you wish to raise a complaint on how we have handled your personal data, you can contact Rachel Thomas (dataprotection@euskills.co.uk) who will investigate the matter.
