

# **NSI AUTHORISATION EVIDENCE FORM FOR CONTRACTORS**

THIS FORM IS NOT TAKEN FROM NSI 30 AND IS FOR USE BY CONTRACTORS TO DOCUMENT EVIDENCE AND FOR INVIGILATORS TO CHECK THAT THE CONTRACTOR HAS MET PRE-REQUISITES PRIOR TO SITTING AUTHORISATION E-LEARNING

Contractors wishing to achieve authorisation under National Safety Instructions or National Grid Safety Documentation must provide evidence of experience and/or training as a pre-course requirement as detailed below.

This is to ensure that people without experience in the desired authorisation will not be authorised in a one off visit.

### Safety Rules (ROMP)

Authorised as a CP NSI 6 full & 8 limited.

2 ROMP documents held under **Personal Supervision** of a ROMP authorised CP within last 12 months

#### NSI 2- Earthing High Voltage Equipment

Authorised as a CP NSI 6 full & 8 limited.

Read NSI 2 Rules & Guidance.

Evidence of two occasions in the application and removal of **Drain Earth(s)** under **Personal Supervision** of an NSI 2 authorised **Competent Person** within last 12 months or NSI 2 Practical Course delivered by the Academy.

#### NSI 4- Work on or Near High Voltage Overhead Lines

Authorised as Person/ BESC/AME OHL

9 days on-site experience.

CPA and CPB-Read relevant sections of NSI 4

CPC- Read relevant sections of NSI 4

Evidence of two occasions in the application and removal of **Drain Earth(s)** under **Personal Supervision** of an NSI 4 authorised **Competent Person** within last 12 months or NSI 4 Practical Course delivered by the Academy

## NSI 9- Testing High Voltage Equipment

Authorised as a CP NSI 6 full, NSI 8 limited & NSI 2 limited

Read NSI 9 Rules & Guidance

Evidence of two occasions in the application and removal of **Primary Earth(s)** under a Sanction for Work and under the **Personal Supervision** of an NSI 9 authorised **Competent Person** within last 12 months
